## 2019 Bar Stool Open RULES & Judges Instructions

*By Land or By Sea, Rain or Shine*

- Each team will be made up of four players.
- There will be a shotgun start at 9:00 AM. August 10th
- Teams must pick up their card at the bar where they signed up. They then can start play at any bar of their choice. Teams may visit any bar at random but must complete all bars by 6:00pm to be eligible for prizes. Each team must be finished by 6:00 PM and your score card turned in at your last hole. Teams in line to play a hole may complete that hole even if time has expired.
- Lowest Team score wins. In the case of a tie, prize money will be divided evenly. All rulings by the official judges will be final.
- **Instructions for BSO Judges:**  
Collect scorecards as soon as they arrive
- There will be no practice shots.
- All balls hit "out of bounds" will result in a one stroke penalty. The ball is then put in play one club head from the *OIB* marker.
- 4 stroke maximum per person per hole, (pick after three strokes).
- Each player must furnish his or her own ball and putter.
- No helping the golfers in how to hit the ball for a hole in one.
- Mark each players score on the team card and **then total the team score.** Be sure to stamp the appropriate letter at bottom of each team card. Return the score card to each team.  
Return the scorecard to each team before they proceed to the next hole unless this is their final hole at which time you will keep card.
- As the last team finish judges should summarize totals on all score cards in their possession and maintain custody of cards, cleanup the area, collect the hole signs and wait for the BSO Chair or representative to pickup all items.
- IMPORTANTLY: While we want everybody to have a good time, it is absolutely imperative that we maintain good order. If any team gets disorderly or wild, they are to be warned and if they do not respond to the warning, they will be disqualified and will not be allowed to continue to play for the remainder of the day.
